General Session Minutes February 26, 2024

1. Call to order

Meeting called to order at 11:59 a.m.

2. Roll call of members

Present: Board Chairman Drye, Board Members Beck and Norman

3. Consent Agenda:

There were six calls last month, mainly public assists. One patient was flown and was doing well last he heard.

Minor fixes were done at the crew cabin and an extensive list made of what remains to be repaired. Repair costs have not been discussed with the auxiliary. Before any work is done, the repair costs need to be brought to the Board for a decision on how they will be paid for.

The gas pumps are being worked on today. The company that works on fuel tanks will take care of everything on the EPA list. If they cannot do something they will let us know who can fix it.

HUD paperwork continues. It appears HUD will accept the USFS reports saving the district time and money.

Volunteers will attend a wildland refresher. A wildland refresher is done each year ahead of fire season for all members. The Arizona Wildfire Incident Management Academy is during spring break in mid-March. Crown King members are attending on scholarships.

It might be possible to secure a contract through the federal government to reimburse the district to pay for those staffing the air curtain incinerator. Work on pile burning is slow but steady and will continue until fire season begins.

A set of turnouts was purchased for the new Reserve. WVFD's Training Captain and Ryan are working with the volunteers to ensure they can sign on to all relevant programs.

Chief Smith will provide the Board with an updated picture of the ATV ambulance. The air conditioning unit was ordered.

The reimbursement check from the fuels grant will be deposited.

b. Fire Board Chairman's Report:

1. County grant

It is planned to start utilizing that grant.

5. Report from the Crown King Fire Auxiliary

Board members thanked the auxiliary for everything they do for the district.
